

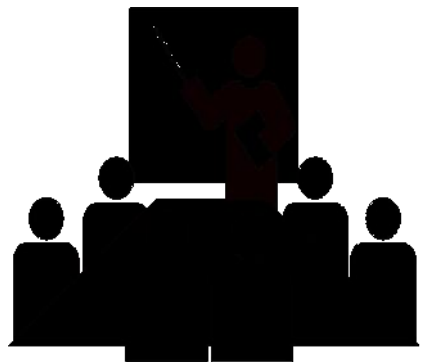

Goodacre Training Pass

Goodacre's Training Pass is offered to individuals and companies who need to meet their minimum number of hours each year to maintain or reach their required regulatory status.

Quite simply, the Training Pass allows individuals to select training from Goodacre's wide ranging portfolio of courses on dates which suit. When training has been completed, CISI members can log their hours on the CISI system or request a formal certificate from Goodacre.

Goodacre runs a range of courses each month as well as several larger events, which also qualify for CPD hours, such as the Securities Industry Conference. In 2009 this Conference featured presentations from Xavier Rolet, The London Stock Exchange Chief Executive and Angela Knight, the Chief Executive of the British Bankers' Association. This year the Conference will be taking place on 1st October 2010 at the Royal Bank of Scotland Auditorium. Holders of the Training Pass can secure places at these events at no additional charge.

The Training Pass allows holders to select up to 8 training sessions and 2 other events a year. The charges are as follows:

For individuals: £995 pa or £90 per month plus VAT.

For companies:

3 staff	-	£2.8k plus VAT
5 staff	-	£4.5k plus VAT
8 staff	-	£7k plus VAT
10 staff	-	£8.5k plus VAT
